Project Summary

Hermiston Generating Company is located in northeastern Oregon, nine miles south of the Columbia River. This 474 megawatt modern natural gas-fueled power plant provides power for nearly 500,000 households in the Pacific Northwest. The plant also provides steam to Lamb-Weston's adjacent potato processing plant, supporting the production of the potatoes served by McDonald's and other national restaurants.

Shawn Lockwood, manager of the accounting department, explains, "The ownership structure is quite unique to power plants—it is not a partnership, but a plant that is owned by two different owners: Pacific Power and Sumitomo of Japan. This means that there are two different sets of reporting requirements—one for each owner. And the incumbent accounting system in place was not flexible enough to meet this need."

Why Now

Two years ago, a new power purchase agreement required HGC to change their financial allocation model. This change required complex calculations in order to provide the right information to their owners. HGC found that their existing financial management system could not sustain their expanded requirements and was at its breaking point.

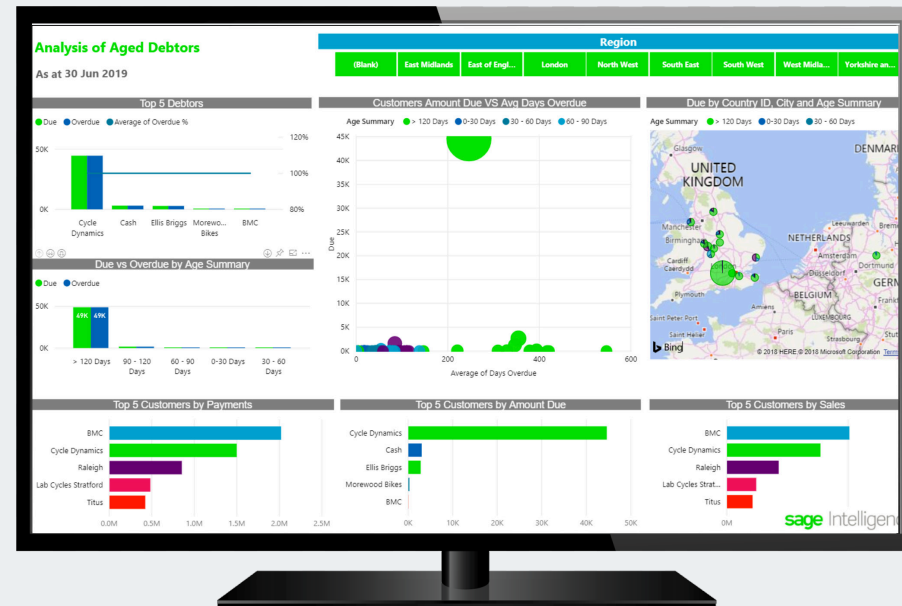
