Cyprian Keyes Golf Club in Boylston, Massachusetts has an impressive historic heritage. America was still a British colony in 1734 when Cyprian Keyes built a home here. Almost two centuries later, a local industrialist bought a mansion in England and had it reassembled on the property.

Cyprian Keyes uses a point-of-sale (POS) system developed specifically for the golf industry, managing everything from pro shop to restaurant and bar sales. But it lacked accounting capabilities. When the club adopted a new POS, it went shopping

the POS and financial system," Rappaport says. "Now all revenues recorded from the golf shop and restaurant transfer over to the general ledger with one simple step."
