Bellinson calls the former system "clumsy" when it came to creating reports. Extrapolating numbers for marketing purposes required a lot of manipulation. "Sage BusinessWorks, however, lets us create a wide variety of reports with a few clicks of the mouse," he comments. "It's set up in an intuitive manner, making it very easy to get the analyses we need. This is saying something, because none of us here are accountants."
