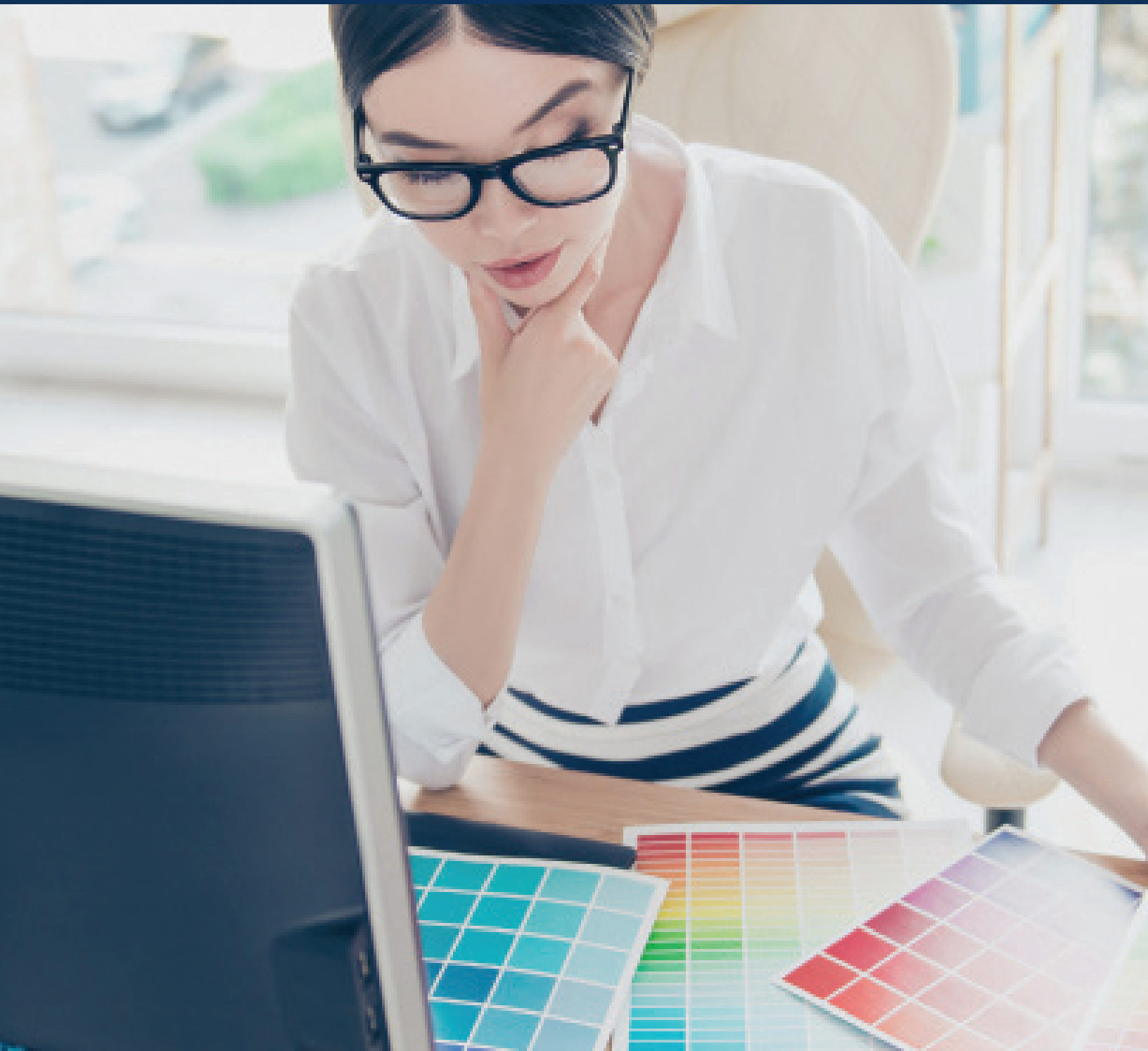

Each print edition reaches over 3,000 business addresses, while the digital version is delivered to over 10,000 professionals and receives an average of 15,000+ impressions.

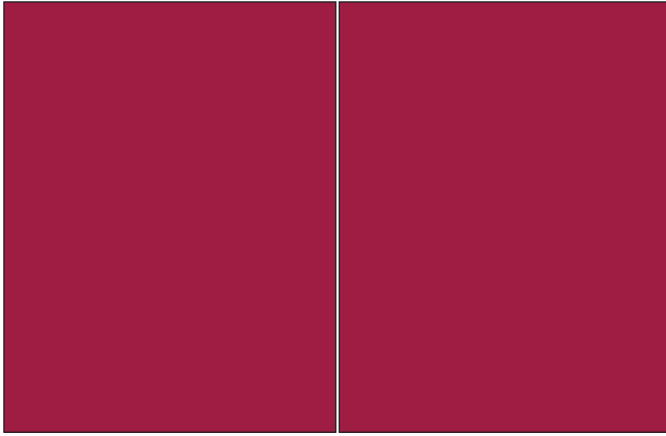

All sizes below include a 1/8" bleed, except the 1/4 page ad, which requires no bleed.

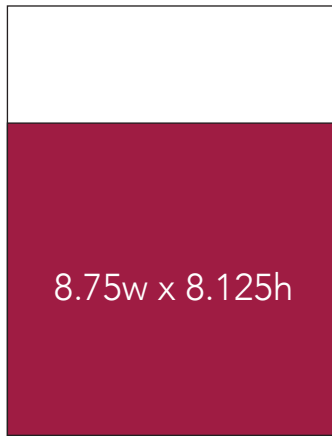


Two-Page Spread



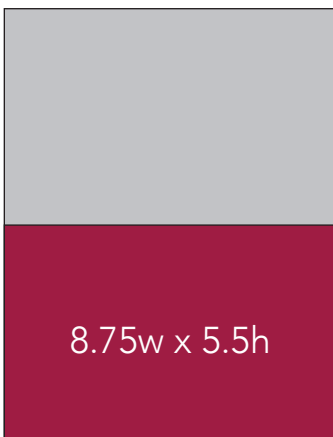

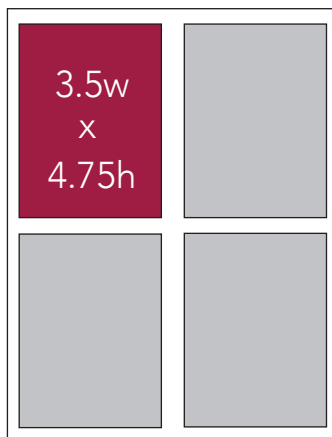

Print Specifications & Ad Requirements

- All artwork must be supplied at 300 dpi (high resolution).
- We prefer PDF format, but .EPS, .AI, and high-resolution .TIFF files are also accepted.
- All color artwork must be in CMYK mode; black-and-white artwork must be in either grayscale or Bitmap mode. RGB mode artwork will be converted to CMYK mode, which results in a color shift.
- All fonts should be converted to outlines. If not, we reserve the right to use an alternative font. All images must be embedded in the file.
- Text placed too close to the edge of bleed ads may be cut off. Please keep text at least a 3/4 inch from the outside edge. The actual bleed dimension is 0.125 inch all around.

We reserve the right to adjust pricing based on standard market values and when considering advertiser ROI. We make every effort to keep the prices on this document and the website accurate and up-to-date.

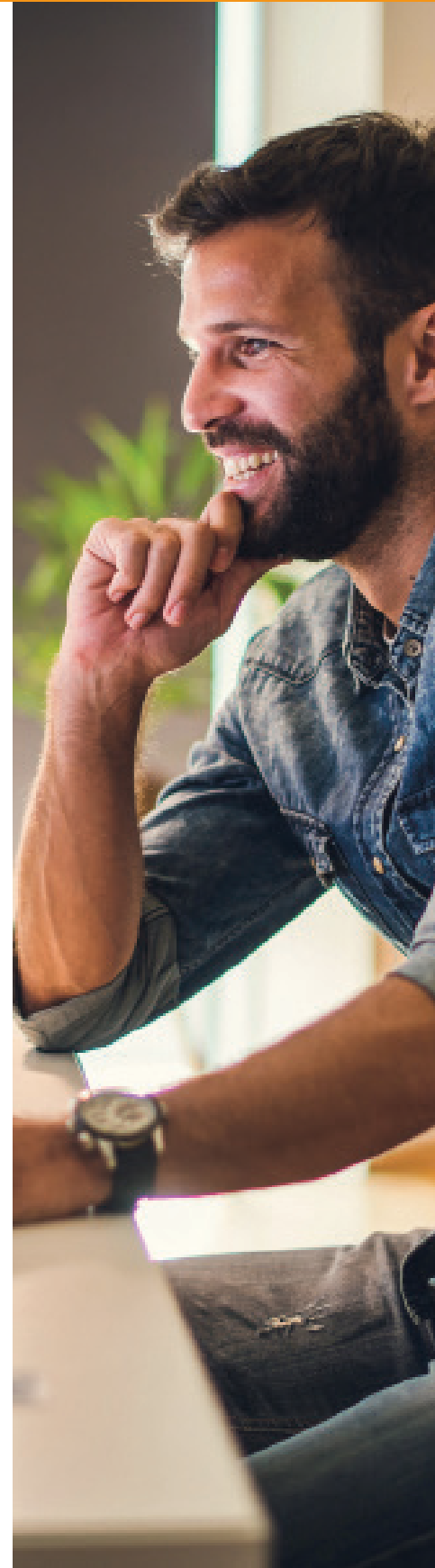
